**CHAMBER OF COMMERCE COMMITTEE FOR

This is an eleven member committee of the Muskogee Chamber of Commerce. It meets to make recommendations to the Chamber for encouraging, promoting, and fostering convention and tourism development for Muskogee. The Mayor and a Council appointee serve on the board. Six (6) at-large members are appointed by the City Council and serve a three (3) year term. Chairman of the Chamber and a Board Member of the Chamber also serve. The Chairman of the Convention and Tourism Development Committee shall serve a one (1) year term and may be reappointed for an additional one (1) year term at the pleasure of the Chairman of the Chamber. This function of the Chamber is funded through the Muskogee Hotel Tax Ordinance 3733-A, and is a contract between the City and Chamber which is reviewed annually. Committee meets third Wednesday of the month at the Chamber of Commerce Board Room, 310 W. Broadway.

The Board shall be composed of nine members, inclusive of at least two members of the Council, all of whom shall be residents of the City who shall be appointed by the City Council. Terms are for 5 years. Meets by Special Call. No members of the Board, after serving one full term, shall be eligible for reappointment until one year shall have elapsed since his or her last service on the board.

## CIVIL SERVICE

Created by City Charter the Civil Service Commission which shall be composed of three members, one of whom shall be selected and appointed by the City Council to serve for a period of six years from the date of the appointment, one to be appointed by the active members of the Fire Department of the City of Muskogee to serve for a period of five years and the two members so selected and appointed to select and appoint a third member who shall serve for a period of four years from the date of appointment. The selection and appointment of successor of each member whose term expires hereunder shall be made in the same manner as provided for the selection of membership of said Board. All members of said Commission shall serve without compensation. The Civil Service Commission shall select one of its members as Chairman and one as Secretary. No person shall be appointed to said Commission who is employed by the City or other governmental subdivision. Meets by Special Call, City Hall, 3rd Floor Council Chambers. Five to nine members serve in advisory capacity to City Council in matters involving structures and areas of historical, architectural and/or cultural significance and proposes recognition and designation of such historic preservation. Whenever possible (2) members should be professionals in the fields of law, history, architecture, or archeology, 3 year terms. Meets by Special Call, 2nd Floor Conference Room, City Hall. (quarterly) No members of the Board, after serving one full term, shall be eligible for reappointment until one year shall have elapsed since his or her last service on the board.

## MARTIN LUTHER KING JR. COMMUNITY CENTER TRUST AUTHORITY

It is the purpose of this trust to finance, operate, construct and administer, hold, and/or receive and administer, for the public purpose, the Martin Luther King Jr. Community Center. There shall be six Trustees: the City Manager for the City of Muskogee and his successor, ex officio, who shall be a nonvoting member but shall otherwise be fully vested to participate as a Trustee; five members selected by a majority of the City Council pursuant to nomination and confirmation methods effective at the time of appointment. The original Trustees of this Trust shall be composed of the individuals who were selected as set forth in paragraph one of the Trust Indenture. All terms are five years after inaugural terms expire. No member of the board, after service one full term, shall be eligible for reappointment until one year has elapsed since his/her last service on the board. All terms to expire on July 31st. Meetings are held on an as needed basis in a Special Call Session at the Martin Luther King Jr. Community Center.

All members of the Board shall have been residents of the City for at least six months next preceding their appointment. Members serve 4-year terms. No member of the Board shall be eligible for reappointment to the board until one year shall have elapsed since his or her last service on the board. Meetings are held on an as needed basis in a Special Call Session at various park facilities on the first Wednesday of the month.

### **UNIFORM BUILDING CODE APPEALS BOARD**

Created by Ordinance 3939-A There is hereby established a Uniform Building Code Appeals Board of the City which shall consist of seven (7) members to be approved by the City Council. Such Board shall be composed of one (1) professional builder, one (1) individual trained in either structural or civil engineering or architecture, one (1) mechanical contractor, one (1) electrical contractor, one (1) plumbing contractor, one (1) individual trained in fire suppression, and one (1) member at large, all of whom shall be residents of the City. The Board shall serve without compensation and shall exercise only those powers enumerated with this Article. Meetings are by Special Call. Terms are for a period of 5 years and no member of the board, after serving one full term, shall be eligible for reappointment until one year has elapsed since his or her last service on the Board.

### **URBAN RENEWAL AUTHORITY**

Effective August 2011 Ordinance 3882-A the City Council shall appoint a Board of Commissioners consisting of five (5) members. The term of office of each such Commission member shall be for three (3) years. There shall be one member chosen from each ward of the City with one member being chosen at large. The representatives from ward one and ward two shall serve initial terms of one (1) year. The representatives of wards three and and ward four shall serve initial terms of two (2) years. The member serving the at large appointment shall serve a term of three (3) years. Only the representatives of wards one and two may be reappointed for one full term of three (3) years. The initial appointments, regardless of the calendar date when such appointments are made, shall expire on the August 31st closest to the full one, two or three-year term to which such members are appointed. Thereafter, and after the expiration of initial terms, all members shall serve terms of three (3) years. All terms of office, including initial appointments shall expire as of August 31st and new terms shall commence on September 1st of the calendar year.

Has power to enter into contracts for sale of bonds, notes or other evidences of indebtedness or obligations. Nine (9) Trustees; One (1) of the Trustees shall be a City Council member who serves coterminous with his term as councilman, and eight (8) trustees appointed to serve three (3) year terms. Members are appointed by City Council. Meets on the 3rd Wednesday of the month in the Batfish Board Room, 9:00 a.m., 3500 Batfish Road. No member of the board, after serving one full term, shall be eligible for reappointment until one year has elapsed since his or her last service on the board.

## WELLNESS INITIATIVE COALITION

It is the purpose of the Coalition created in Section 2-530 to serve in an advisory capacity to the Parks and Recreation Department and the City Council as to matters dealing with the health, wellness and well being of local community. The Coalition shall make recommendations and give advisory opinions to the Parks and Recreation Department director and to the City Council for improving, promoting the health, wellness and well being of the community and for enactment of resolutions and ordinances which will be of benefit to the citizens of the city in fulfilling the purpose of the Coalition. The Coalition shall be composed of nine members, five members to be approval by the City Council. The remaining four members shall be the Mayor of the City of Muskogee and his/her successor, the City physician and his/her successor, the Director of the Muskogee County Health Department and his/her successor and the Chairman of Turning Point or his designee and his/her successor. Terms of office of members of the Coalition shall be as follows: (1) Their term of office for the four (4) members designated by office shall be permanent or until such time as this provision is amended. (2) The remaining members of the coalition shall be appointed for terms of four years. Meets by Special Call. No member of the board, after serving one full term, shall be eligible for reappointment until one year has elapsed since his or her last service on the board.
